



# EASTERN CANADA DISTRICT OF KEY CLUB INTERNATIONAL RULES GOVERNING THE TALENT CONTEST

1. Each Key Club may have no more than one act entered in the Talent Contest.
2. A club's entry may take any form as long as it is entertaining and in good taste. To help in classifying entries, the following are categories for acts:

Vocal Solos	Group Singing (duets, quartets, etc...)
Instrumental (solo or group)	Dancers (solo or group)
Skits of Variety Acts	Readings or recitations
Miscellaneous (magicians, tumblers, etc...)

3. A Statement of Entry for each act must be filed with the Eastern Canada District of Key Club International. This form is attached and must be signed by the Key Club President, Kiwanis Advisor, and Faculty Advisor attesting to the fact that they approve the act and that it is in good taste.
  4. All participants in an act must be official members in good standing with Eastern Canada District of Key Club International and their local club. In the case of a group act, **all members must be from the same club.**
  5. All acts entered in the Talent Contest will be required to demonstrate their ability and entertainment appeal at preliminary auditions (time and place to be announced in the convention programme). At this time, the top six (6) most entertaining acts will be selected to appear in the Talent Show as finalists.
  6. The time limit on each performance **is six (6) minutes.** Anyone exceeding this limit will be disqualified.
  7. Stage preparation time **must not exceed five (5) minutes.** Failure to comply will result in disqualification.
  8. Any materials that are needed for each performance must be supplied by the contestants who participate in that performance.
  9. Suitable awards will be presented to the three most outstanding acts.
  10. Judging for this contest will be based on the following criteria:

Content	20 points
Performance	20 points
Audience Response	20 points
Poise	20 points
Personal Evaluation	20 points
  11. The decision of the judges will be final. No changes or alterations will take place after the judges and the Chairperson of the judges have certified the results.
